The Children's Legacy Fund (Sports, Arts and Recreation) - is designed to remove financial obstacles, so Indigenous children are not excluded from important cultural, social, and developmental opportunities.

The fund supports opportunities for Indigenous children and youth up to 17 years of age who due to financial barriers would otherwise not have the opportunity to participate in sports, arts, and recreational programming. The focus of the funds is to support youth in community level opportunities. Applications are reviewed monthly by a committee comprised of Ma Mawi Wi Chi Itata Centre Board and staff members.

Families may submit **one application per twelve-month period**, with a **maximum allocation of \$500 per family**.

Please review the following eligibility criteria before applying - **Only fully completed applications with required documentation will be considered.**

- Applicant must be Indigenous (First Nation, Métis, Inuit). Documentation demonstrating Indigenous ancestry is required.
- Applicant demonstrates financial need that would otherwise prevent their child(ren) from participating in sports, arts, or recreation.
- Applicants must reside within the City of Winnipeg, MB
- Applicant has not received funding through the Children's Legacy Fund in the past twelve months. (*Applications will not be considered if the family/child(ren) have received funding in the last 12 months)
- Approved funding is paid directly to the program/association. A copy of the fee schedule and program contact is required. Note: the fund does not provide reimbursement for fees or purchases already paid.
- Applicant agrees to provide appropriate receipts for any costs related to equipment purchases approved through the Children's Legacy Fund.
- Preference will be given to families currently engaged in Ma Mawi Wi Chi Itata Centre programs.
